SUBJECT: Bear Pen Creek, Sonoma County

A Biological inventory was taken on 09/11 of 1995 on Bear Pen Creek. Single pass electrofishing was the method used.

The inventory of reach one was conducted starting at the confluence with Austin Creek, 30 yards from King Ridge Road in habitat units 1-12. In pool, riffle and glide habitat types 130 0+, 5 1+ and 1 2+ steelhead were observed along with 8 stickleback, 2 sculpin, 1 roach, 8 frogs and 1 Giant Pacific salamander.

The inventory of reach two was conducted 100 feet below a summer dam in units 190-211. In pool, riffle, run and glide habitat types 109 0+, 12 1+ and 2 2+ steelhead were observed along with 7 roach, 10 frogs and 179 juvenile Giant Pacific salamanders.
